# 2022 Katy Youth Football® Winter Classic Tournament The Rules of the Game Official Playing Rules and Code of Conduct

This document contains the official playing rules for Katy Youth Football® Winter Classic Tournament. Katy Youth Football® follows the current version of the National Collegiate Athletic Association (NCAA) Football Rules as adopted and amended by the University Interscholastic League (UIL) for High School Football in the State of Texas, with the Following additions, exceptions and clarifications as enumerated herein.

# Official Playing Rules

## I. Player Eligibility

1. Players must meet the tournament age requirements as follows: (Note all divisions may not be offered)
  - a. 6U: Must be 6 on 8/1/2022 (Cannot be 7 years old on or before 8/1/2022)
  - b. 8U: Must be 8 on 8/1/2022 (Cannot be 9 years old on or before 8/1/2022)
  - c. 9U: Must be 9 on 8/1/2022 (Cannot be 10 years old on or before 8/1/2022)
  - d. 10U: Must be 10 on 8/1/2022 (Cannot be 11 years old on or before 8/1/2022)
  - e. 11U: Must be 11 on 8/1/2022 (Cannot be 12 years old on or before 8/1/2022)
  - f. 12U: Must be 12 on 8/1/2022 (Cannot be 13 years old on or before 8/1/2022)
  - g. 13U: Must be 13 on 8/1/2022 (Cannot be 14 years old on or before 8/1/2022)
  - h. 14U: Must be 14 on 8/1/2022 (Cannot be 15 years old on or before 8/1/2022)

## II. DUTIES OF COACHES AND TEAMS

1. There shall be no smoking, tobacco chewing, or drinking of alcoholic beverages on the field of play during practice or games. Tobacco, alcoholic beverages and drugs are not permitted on any KISD premises at any time per KISD policy. KYF® agrees with and supports KISD policy in this matter. This policy also applies to other KYF® events, or any premises in which official KYF® activity is conducted.
2. ANY PERSON SUSPECTED TO BE UNDER THE INFLUENCE OF ALCOHOL OR DRUGS WILL BE REQUIRED TO LEAVE THE KISD PROPERTY OR OTHER KYF® USED PREMISES. Any coach who is suspected to be under the influence of alcohol or drugs at any game or practice shall be subject to Board disciplinary action up to and including removal as coach.
3. All coaches and fans are expected to exhibit appropriate behavior while at KYF® games, i.e. no cursing, obscenities, or otherwise unsportsmanlike conduct. Vulgar language is strictly prohibited. Coaches are expected to encourage and enforce this behavior among their players, cheerleaders and parents. See KYF® Code of Conduct
4. Unsportsmanlike conduct of a coach or spectator is subject to review by the President, VP Football Operations, and Tournament Director. Disciplinary action may result in a one or more game suspension, or removal from tournament.
5. No pets are allowed anywhere on KISD property or other KYF® premises.

6. Coaches, players, and cheerleaders shall remain within the 20-yard line markers during the playing of games. All fans must stay behind the line or cones marking 4 yards back from the sideline. No coaches are allowed on the field of play, and no one is allowed in or around the end zone area. This rule applies to all spectators, players and coaches — not just those associated with the game in progress. When games are played on competition fields with grand stands – No parents or spectators will be allowed inside the fenced in field area at any time. All spectators must watch from the grandstand. No outside photographers will be allowed within the field area at any time.
7. All head coaches have the responsibility of ensuring any and all assistant coaches, players, cheerleaders, and fans do not bring discredit to their team by word or action, such as use of foul language, playing dirty football, or participating in unsportsmanlike cheers.
8. The Head Football Coach is responsible for ensuring that NO music is to be played during a game. Music may be played before the start of a game, during halftime and at the conclusion of the game. “Radio edit” music only. Absolutely no explicit lyrics are allowed. No Music may be played during Championship games.
9. Loud speaker/megaphone announcements and/or play-by-play of any sort during any game are prohibited.
10. Drones of any kind are prohibited from being flown over any KYF® game, or on KISD Property.
11. It is recommended that all coaches inspect players or cheerleaders equipment to be sure it is of sufficient quality to be safe and protective, and is properly fit.
12. Each team will provide personnel to staff a three-person chain and down marker crew for the game (If needed and not filled by volunteers). The three-person crew will consist of two members from the home team and one from the visiting team. The chains and down markers will be run from the home team’s sideline, unless professional video services are employed by the league. In this case, the chain and down marker crew will function on the sideline opposite the camera.
13. Coaches, referees, and Board members are responsible for enforcing all standards of conduct.
14. Use of cellular phones, hand held radios, “walkie-talkies”, or any other personal portable communications devices to communicate with coaches or individuals either on the field, on the sidelines, or in the stands is prohibited.

### III. GAMES

1. All games will be played by NCAA rules as adopted by the University Interscholastic League (UIL), except as noted herein.
  - Non-Championship Games: 10 Min qtrs. Running clock, with stoppage during last 2 minutes of each half (Last 2 minutes of each half timed per NCAA/UIL Rules).
    - i. Each Team will be allowed three (3) – 30-second time-outs per half
    - ii. Half-Time will be 5 minutes
  - Championship Games: 10 minute quarters – Clock stoppage per NCAA/UIL Rules
2. All games will be played according to the schedule prepared by KYF®. KYF® will distribute schedule no later than first day of tournament. THE SCHEDULE IS SUBJECT TO CHANGE AT ANY TIME AT KYF's SOLE DISCRETION.
3. Any team failing to field the required number of players (15) within ten minutes of scheduled game time may forfeit said game and the game could be recorded as a game of record at the discretion of the KYF® President, VP-Football and Tournament Director.
4. All teams are required to play each game until conclusion unless authorized by the President, VP-Football or Tournament Director after consultation with the referees.

Referees, coaches, and the Board may call a game upon mutual agreement due to weather or other circumstances. If games already in progress are called due to weather they will not be completed unless they have impact on championship berth.

5. At least two officials will be used in all games. The Board will provide TASO Certified Game Officials for all games.
6. Coaches are allowed to have water on the field for players, as long as it does not slow down or interfere with normal play. Water from the sidelines cannot be brought out between plays unless a time-out has been called or the referees have stopped play specifically for that reason.
7. In the interest of safety, no ladders will be allowed on KISD property, or any other KYF® premises, during games.
8. Extra points are awarded as follows:

Run	1 point
Forward Pass (6U thru 10U)	2 points
Forward Pass (11U thru 14U)	1 point
PAT Kick (10U thru 14U)	2 points

***The defense can score on an extra point. 2 points awarded.***

9. Scrimmage Kicks – (6U thru 9U) – Punts
- When a team declares a punt, the team **must punt**. Fake punts are **NOT** allowed.
  - Center may not be contacted until ball is kicked
  - Rushing by the defense is not allowed on a punt (a free scrimmage kick in 8U).
  - Neither the offense nor the defense may cross the line of scrimmage until the ball is kicked away
  - If the snap from center to the punter is dropped or mishandled and touches the ground, the punter is able to pick up the ball and continue with his kick. The free kick rule is still in effect.
  - Snaps must be made between the legs.
  - **Field goals/PAT Kicks - Not Allowed**
10. Scrimmage Kicks – (10U thru 14U) - Punting, Field Goals & PAT Kicks
- When a team declares a punt, no one on defense is allowed to line up over the center. The long-snapper cannot be hit until after the ball is kicked away. If a punt is not declared, the center may be covered.
  - Fake punts ARE allowed. If during a fake punt the punter returns under the center, the center can be covered.
  - Rushing the punter is allowed. Rushing Fields Goals and PAT Kicks is allowed
  - Only defensive down-linemen in a 3 or 4-point stance (no more than six), lined up no wider than head up on the last down O-lineman to their side, can rush a field goal, punt or PAT Kick. **No rushing is allowed from a position wider than the last down O-lineman. Penalty is 5 yards and replay of down.**
11. Overtime: Non-Championship Games: teams will play successive overtime periods per NCAA rules starting from the 10-yard line until a winner is declared. Championship Games: Teams will play successive overtime periods per NCAA rules starting from the 20-yard line until a winner is declared.
12. Ball size is according to division: **(Full Leather Balls Only)**
- 1) 6U thru 9U K2 will be the game ball
  - 2) 10U & 11U TDJ will be the game ball
  - 3) 12U & 13U TDY will be the game ball
  - 4) 14U TDS (High School Ball) will be the game ball
13. Helmet visors must be clear; player's eyes must be visible
14. All players must use mouthpieces on the field of play at all times.
15. Every player is expected to maintain a sportsmanlike manner at all times. **Fighting will not be tolerated.** Unsportsmanlike conduct by a player is subject to review and could

result in a one or more game suspension. Any player ejected from a game by a referee will be automatically suspended for the remainder of the game, as well as the 1<sup>st</sup> half of the next game. **Any player ejected for fighting will be suspended for the remainder of the tournament.**

**16. Ejection of a parent, spectator or coach from a game for inappropriate behavior by a game official or a KYF® board member will result in parent/spectator/coach being removed from property and not allowed on any KYF® Premises for remainder of tournament. The player will not be affected by the parent's suspension.**

17. Each player's football helmet must be NOCSAE approved.

18. Seeding from Pool Play: In the event the tournament utilizes pool play to determine bracket seeding the following criteria will be utilized: The winning percentage will be utilized to calculate seeding. Tie-Breaker steps. For teams with identical winning percentage the following steps will be utilized to break a tie:

1. Head-Head (only applicable for two-way tie)
  - i. Note: If three or more teams are tied the tie-breaker will begin with step 2.
2. Points Allowed
3. Points Scored
4. Coin Toss

Note: If three or more teams are tied and a team is eliminated or awarded a seed during any tie-break step, the tie-breaker then immediately reverts back to step 1 for the remaining tied teams.

#### **IV. Judgment Calls, Protests, Infractions and Penalties**

1. Referees shall be the final determiner of all actions and behavior on the field of play. All judgment calls shall reside totally with the referees and are not subject to Board review.
2. Referees assigned to a game or any Board member may cause the removal or ejection of any person from KISD property or other KYF® premises for violation of any of these codes of behavior. Upon removal or ejection, that person must leave the field and premises immediately, may not remain in the proximity of the field, and possibly may not return for any subsequent games for the remainder of the tournament.
3. Protests can be made only on rules violations. No protest will be considered which is submitted over a referee's judgment call.
4. All protests must be submitted immediately to the Tournament Director or KYF® VP-Football and KYF® President. Each point of protest and corresponding rule must be cited in the protest.



5. A review board of five (5) non-affected Executive Committee members shall render the final decision on the validity of any protest. If this condition cannot be met with (5) non-affected Executive Directors the President will appoint additional directors to complete a (5) person independent review panel for the specific protest. All decisions are final.
6. Any team found to be in violation of the player eligibility requirements may forfeit any game an ineligible player participated in.

# Katy Youth Football®

## Parent/Spectator/Coach/Player

### Code of Conduct

Katy Youth Football believes that: participation in any sports program plays an important role in promoting the physical, social, and emotional development of our youth. It is essential for KYF® to provide a positive and enjoyable learning experience for our children; teaching sportsmanship, fair play, integrity, honor, respect, loyalty, personal courage, and dedication through the game of football and cheer. Furthermore, parents, coaches, spectators, and officials involved in youth sports events should be models of such statements and should lead by example by demonstrating fairness, respect, and self-control. Listed below are behaviors that are expected by our parents, spectators, coaches and players:

- Encourage all players and praise great plays from both teams.
- Keep all comments positive and support the efforts of the coaches, officials, and the league.
- Only players and coaches are allowed on the field. **No exceptions.**
- Leave the coaching to the coaches.
- Criticizing the officials, coaches, opponents, or fans will not be tolerated.
- Only coaches and players shall speak to the officials.
- Understand that all officials do their utmost to be impartial; they try their best to provide a safe and suitable environment so that the game is well played.
- Profanity, drug, alcohol, or tobacco use during any Katy Youth Football event is prohibited and offenders will be immediately removed from the field.
- Children who are spectators and are not participating at that time are the responsibility of the parent or guardian. The child needs to be supervised at all times and remain within close proximity of their parent or guardian. Parents must supervise and prevent behaviors which interfere with game play or damage the property of Katy Youth Football or Katy ISD.
- **Ejection of a parent, spectator or coach from a game for inappropriate behavior by a game official or a KYF® board member will result in parent/spectator/coach being removed from property and not allowed on any KYF® Premises for remainder of tournament. The player will not be affected by the parent's suspension.**
- **Any parent or spectator that threatens an official or coach will be suspended for the remainder of the tournament, and not allowed on any KYF® Premises.**
- **Any Player ejected from a game by a game official will be suspended for the remainder of the game, as well as be suspended for the 1<sup>st</sup> half of the team's next game, if applicable.**
- If an issue arises during the game, please locate a KYF® board member to discuss your concerns or you can speak with the coach following the game. Arguments or discussions should be addressed with the coach following the completion of the game.
- Katy Youth Football expects **ALL** coaches and parents to create a fun, positive, and secure environment for the players and cheerleaders.

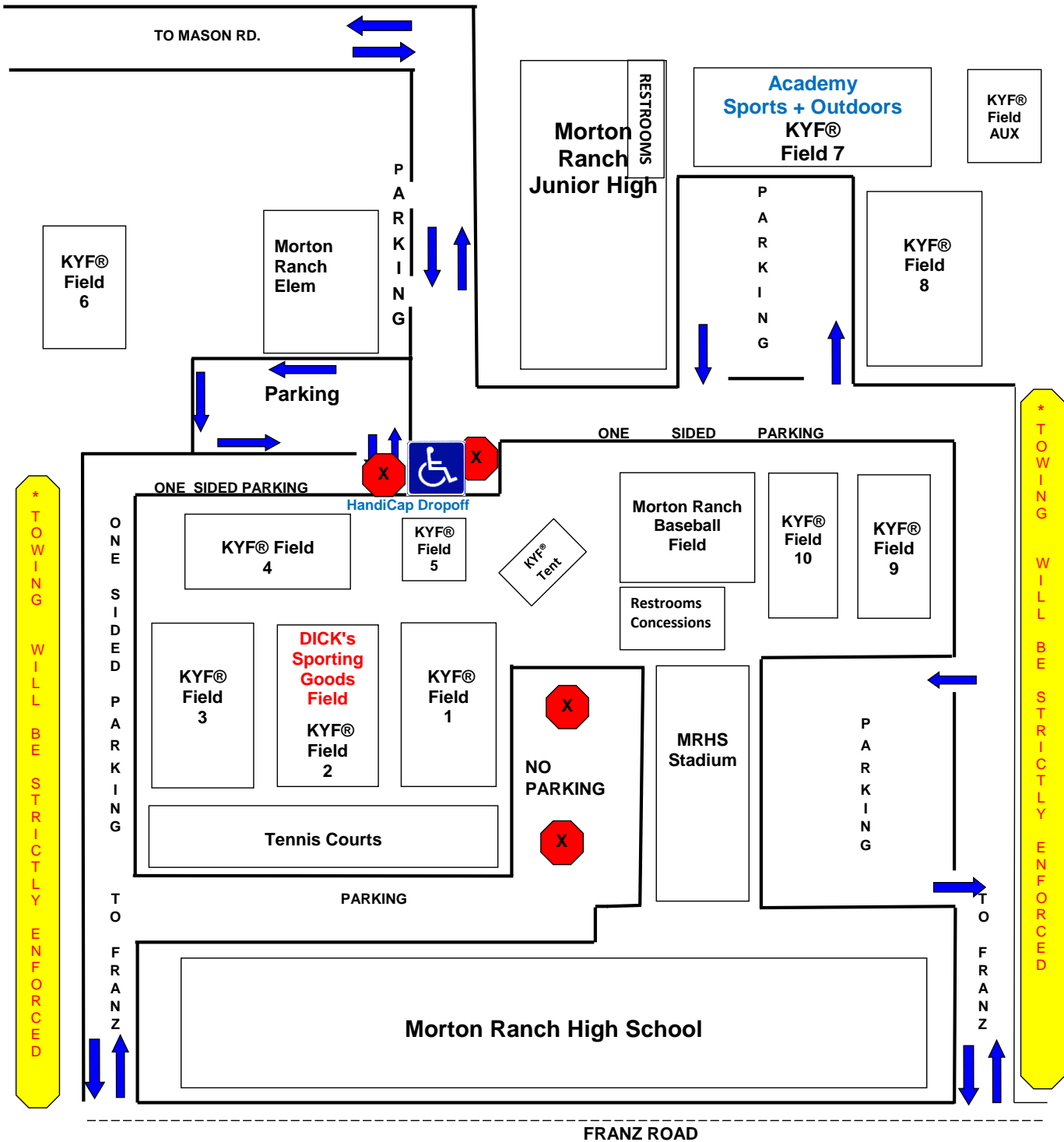
